AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE COUNTY OF IMPERIAL RELATING TO THE COUNTY ASSESSOR

Ordinance No. 1456

The Board of supervisors of the County of Imperial, State of California, ordain as follows:

SECTION 1: Chapter 2.24 of Title 2, Section 2.24.030, "Collection of Fees," of the Codified Ordinances of the County of Imperial, is hereby rescinded.

SECTION 2: A new Chapter 2.24 of Title 2, Section 2.24.030, "Collection of Fees," of the Codified Ordinances of the County of Imperial is hereby enacted, to read as follows:
